- **18.162. - **18.170. SPARROW PARK:** Councillor Clough reported that he had identified a possible craftsman able to produce the name board for the park. Members requested he make the necessary contact to see if the work could be done.
- **18.171. ELIZABETH AND RICHARD WILSON CHARITABLE FUND**: The clerk reported that the 2017/2018 funding contribution was still awaited from the fund trustees with the current balance available in the fund of £3.10. No new application had been received.
- **18.172. THE WEIR CHILDREN'S PLAYGROUND:** Members agreed that a new log be purchased for the sandpit climbing area. Members agreed that the missing letters from the compass feature be replaced with brass epoxy resin infills.
- **18.173. PARISH LENGTHSMAN:** The clerk reported that the parish lengthsman continued to carry out work throughout the village including assisting Councillor Clough with the installation of the new Evolis Radar Speed sign.

**18.174. SPEED DETECTION DEVICE:** Councillor Clough reported that the Evolis Radar Speed Sign had been positioned in Borwick Lane and was operational. The sign was a major improvement on the previous equipment and would be programmed to record and produce data on traffic speed trends in the near future.

Members thanked Councillors Clough and Peter Doey for their work installing the sign.

- **18.176. REGISTRATION OF WARTON PARISH COUNCIL LAND WITH THE LAND REGISTRY:** Councillor Peacock agreed to attempt to specify the actual land designated as Senset Well as apposed to the brindle path leading to it and report back to the next meeting of the parish council.
- **18.177. PARISH COUNCIL WEBSITE:** The clerk reported that input of parish council data had continued.
- **18.178. WARTON AND MILLHEAD COMMUNITY ROADWATCH SCHEME:** The clerk reported no further expressions of interest in joining the scheme had been received.
